Rate Information: This Account is an interest bearing account. The interest rate on the account is 3.20% with an annual percentage yield of 3.25%.

The interest rate and annual percentage yield will not change for the term of the account. The interest rate will be in effect for 13 Months. Interest begins to accrue on the business day you deposit noncash items (for example, checks). Interest will be compounded monthly and will be credited monthly. We will mail the interest in a check to you or deposit the interest in an account that you designate. The annual percentage yield assumes interest will remain on deposit until maturity. A withdrawal will reduce earnings.

**Balance Information:** We use the daily balance method to calculate the interest on the account. This method applies a daily periodic rate to the principal in the account each day.
